It is within walking distance of the village amenities and has easy access to the nearby Town whilst also benefiting from being close to the beautiful Sherwood Forest Countryside. This property has a new modern kitchen and has been redecorated throughout to include new floor coverings.

At the front of the property there is gated access leading to a UPVC double glazed entrance door into:

HALLWAY

With ceiling light point, stairs to first floor landing and door opening up into:

LOUNGE

The lounge has UPVC double glazed window to the front, radiator, power points, TV aerial point, telephone point and ceiling light point.

Wooden panelled door with chrome door furniture into:

DINING - KITCHEN

The kitchen which has two UPVC double glazed windows to the rear, thermostatically controlled radiator, ceiling light point, numerous power points and laminate flooring. The room is separated into a kitchen and dining area creating a great living space. The kitchen has been newly fitted with a range of wall and base units with roll top work surfaces and coordinated tiled surround, integrated stainless steel oven and grill with four-point gas hob, single drainer stainless steel sink with chrome mixer taps, space and plumbing for washing machine, space for dryer, space for fridge freezer, wall mounted boiler and UPVC double glazed door to rear garden. From the kitchen area there is also access to an under-stairs cupboard which is useful for storage.



LANDING

Stairs to the first floor landing with ceiling light point, access to loft space, smoke alarm and thermostatically controlled radiator.

BEDROOM ONE

Panelled door to the main bedroom which is a large double room and has UPVC doubled glazed window to the front, thermostatically controlled radiator, ceiling light point and power points.

BEDROOM TWO

Panelled door to bedroom two which has UPVC double glazed window to the rear, thermostatically controlled radiator, power points and ceiling light point.

Wooden panelled door with chrome door furniture into:

BATHROOM

UPVC double glazed opaque window to the rear, three-piece suite comprising; panelled bath with tiled surround, pedestal wash hand basin with tiled splash back and close coupled W.C. The bathroom has laminate flooring, ceiling light point, wall light, shaver point and extractor fan. There is also a large airing cupboard ideal for storage.



OUTSIDE

The rear garden is of a good size and is mainly laid to lawn surrounded by a mixture of fencing. There is a rear patio area that provides the ideal space for outside seating/dining.

TENANCY INFORMATION

What permitted payments can I expect to pay if I rent a property with Need2View?

When you have agreed on the property of your choice, Need2View will provide you with a Tenancy Application Form. This helps explain not only the next stages of your application, but any permitted payments which are due before you sign your Tenancy Agreement and any which may become payable during and after the tenancy.

This will also include confirmation of the agreed rent and the deposit.

Below is a list of our current permitted payments. At any time you are interested in a property, please ask a member of staff for a full breakdown of permitted payments that may be payable before, during and after a tenancy.

HOLDING DEPOSIT(per tenancy) One week's rent.

This is to reserve a property.

Please Note: This will be withheld if any relevant person (including any guarantor(s)) withdraw from the tenancy, fail a Right-to-Rent check, provide materially significant false or misleading information, or fail to sign their tenancy agreement (and / or Deed of Guarantee) within 15 calendar days (or other Deadline for Agreement as mutually agreed in writing).

SECURITY DEPOSIT (per tenancy. Rent under £50,000 per year) Five weeks' rent. This covers damages or defaults on the part of the tenant during the tenancy and applies to Assured Shorthold Tenancies (AST).

SECURITY DEPOSIT (per tenancy. Rent of £50,000 or over per year) Six weeks' rent. This covers damages or defaults on the part of the tenant during the tenancy and applies to Assured Shorthold Tenancies (AST).

UNPAID RENT Interest at 3% above the Bank of England Base Rate from Rent Due Date until paid in order to pursue non-payment of rent. Please Note: This will not be levied until the rent is more than 14 days in arrears.

LOST KEY(s) or other Security Device(s). Tenants are liable to the actual cost of replacing any lost key(s) or other security device(s). If the loss results in locks needing to be changed, the actual costs of a locksmith, new lock and replacement keys for the tenant, landlord any other persons requiring keys will be charged to the tenant.

If extra costs are incurred there will be a charge of £15 per hour (inc. VAT) for the time taken replacing lost key(s) or other security device(s).

VARIATION OF CONTRACT(Tenant's Request) £50 (inc. VAT) per agreed variation.

To cover the costs associated with taking landlord's instructions as well as the preparation and execution of new legal documents.

CHANGE OF SHARER(Tenant's Request) £50 (inc. VAT) per replacement tenant or any reasonable costs incurred if higher.

To cover the costs associated with taking landlord's instructions, new tenant referencing and Right-to-Rent checks, deposit registration as well as the preparation and execution of new legal documents.

EARLY TERMINATION(Tenant's Request). Should the tenant wish to leave their contract early, they shall be liable to the landlord's costs in re-letting the property as well as all rent due under the tenancy until the start date of the replacement tenancy.

These costs will be no more than the maximum amount of rent outstanding on the tenancy.
